## Note:

- The drafts mentioned above are the drafts available alongside the berths. However, the draft in the channel varies depending on tide.

  Kandla is a tidal port & vessel movements to/from outer anch (OTB) are carried out only during favorable tide. The maximum permissible draft in the chancel is 13 Mtr. However, maximum permissible drafts at individual berths, moorings & anchorages will apply.
- Night navigation is restricted to vessels with length of above 225.5 Mtrs and draft more than 11.50 Mtrs. LPG and Ammonia vessels are handled during daylight hours only. Usually only one pilot is available for carrying out night movements..
- The maximum permissible LOA for the Port is 240 Mtr. However, Vessels upto LOA 255 Mtr may be brought is under specific conditions.
- Vessels usually berth Starboard side during high tide and Port side during ebb tide. If a tanker of 213 MTRS is berth at OJ-2 the length of vessel at OJ-3 shall not exceed 183 M.
- For chemical discharge, most suitable berths are OJ-2,OJ-3, and OJ-4. Phosphoric acid and Ammonia is discharged at IFFCO captive jetty OJ-5 also alternatively at OJ3 as per IFFCO option. OJ6 is captive jetty of M/s Indian Oil Corporation and cater only to vessels carrying cargoes on their account. No other vessels are handled at OJ6
- According to the berthing policy implemented by the port, out of 4 oil jetties (OJ-1 TO 4), 2 berth each for chemical & Edible oil vessels subject to submission of storage terminals ullage confirmation and vessel readiness. And OJ-5 (Iffco Jetty) will be allotted to senior most vessel which one can work in absence of Iffco vessel. Coastal vessels will get priority berthing and the same will consider in chemical group.
- Fresh water/ bunker supply possible
